

EC Band Boosters
September 11, 2006

Kathy called the meeting to order. Minutes from the last meeting were approved.

Sue asked for a report on Kathy's attendance of the EC Athletic boosters meeting. Kathy passed out their meeting agenda, and reported they gave permission for band boosters to sell items labeled East Clinton Astros. Sue will change the special order form and email to Cathy Jones.

Susan presented a treasurer's report. Mr. Minge helped clarify some expenses and band fees are still being collected.

Susan reported a balance of \$3280.64. The uniform account has a total of \$8250.

Uniform drive mailing – update prices on web site and letter. Jackets \$140, pants \$48.50, hats \$35

Mr. Minge has developed a form to withdraw student funds in their virtual accounts. Boosters approved the form.

Fall concert is changed to October 17, Sue will update the web site.

Mr. Minge stressed the need for a small ATV and a pit crew to get the equipment on and off the field. Three or four parent volunteers are needed. Volunteers will receive free admission to games and competitions.

Kathy distributed a class list with names and phone numbers and Mr. Minge presented parent forms with more information. Cathy will compile the information into a spreadsheet and email to volunteer coordinator.

Kathy reported the car wash raised \$275. Sue made the motion that the funds be put toward the uniform drive. Seconded by Susan Thompson. Motion passed.

Kathy reported a new tax ID number for use in purchasing Kroger Cards. Tax ID# 76-0836651. Kathy will follow up with Kroger to purchase the cards.

Kathy reported that volunteers are needed this week to fit uniforms. Jani and Kathy will fit on Thursday.

Two parent volunteers are needed to maintain and oversee the care of the new uniforms. Parent volunteers will be responsible for gathering hat plumes, cleaning uniforms as needed, and making sure uniforms are put away. Jani will make calls.

Astro Success Night, September 22 dinner – shifts from 4-6 and 6-8. Kathy will organize volunteers for this event. School district is advertising and paying for cook. Kathy will ask for donations of food.

Chili supper – October 13

14 volunteers are needed. Sue will contact Strebers for donation of meat.

Kathy asked the group for a motion for the profits from this event. Susan Thompson suggested we divide the monies between the general fund and the individual accounts.

The group discussed the credit system for virtual accounts Cathy Jones devised. Kathy reported success getting parent volunteers using the new system. Sue moved we approve the system, Jani seconded. Motion passed.

Kathy reported she has not confirmed dates with the school district for bingo on November 11 or breakfast with Santa on December 9. She will follow up this week.

Kathy purchased fleece for scarves, the group agreed to sell them for \$8 each.

Cathy Jones presented the group with a revised Scrip info packet. Sue will update the web site. Cathy will email Sue the forms for the web.
